THREE WATER MANAGEMENT DISTRICTS OBTAIN NEW EXECUTIVE DIRECTORS



South Florida WMD Executive Director, Peter Antonacci

As head of the state's largest water management agency, Antonacci will lead the District in carrying out its mission to balance and improve flood control, water quality, natural systems and water supply across a region that serves 8.1 million people.

A seasoned attorney, Antonacci brings more than three decades of experience in Florida state government, finance and law to the District. In his most recent public role, he served as Governor Scott's General Counsel, from 2013 to 2015. He served as a Governing Board member at the Northwest Florida Water Management District, from 2006 to 2012. His public service also includes:

- Florida Commission on Ethics member (2002-2006)
- State Attorney for the 15th Judicial Circuit in Palm Beach County (2012) (Click on the picture for a larger version.)
- Deputy Attorney General of Florida (1990-1997)
- Statewide Prosecutor (1988-1990)

In addition to his public service, he practiced law at the firm of GrayRobinson P.A. in Tallahassee. Antonacci earned his law degree from Florida State University as well as a master's degree in Urban and Regional Planning.



St. Johns River WMD Executive Director, Dr. Ann Shortelle

Dr. Ann Shortelle is the executive director of the St. Johns River Water Management District, where she began work June 1, 2015.

Shortelle has more than 25 years of professional experience in lake, riverine and reservoir management for water quantity and quality. Her experience also includes surface water/wetlands restoration, surface water modeling, permitting and environmental assessments.

She previously served as executive director for the Suwannee River Water Management District (SRWMD) for three years, where she had been actively involved in the North Florida Regional Water Supply Partnership and springs protection.

Prior to taking the helm at SRWMD, she was the director of the Office of Water Policy for the Florida Department of Environmental Protection (DEP), where she helped develop water policy for water supply planning and alternative water supplies, minimum flows and levels, reuse, water conservation, water quality protection and consumptive use permitting.

She holds a doctorate degree in limnology from the University of Notre Dame and a bachelor of science degree in biology from Mercer University. She has authored/co-authored more than 40 publications and presentations on environmental topics.

Governing Board Chairman, Don J. Quincey, Jr., appointed Carlos D. Herd as the interim executive director of Suwannee River Water Management District

ENVIRONMENTAL PERMIT STREAMLINING REMINDER

In 2013, a bill was passed that revised numerous provisions relating to environmental permit streamlining. The bill states “upon authorization from the department, issuance of well permits will be the sole responsibility of the water management district, delegated local government, or local county health department. Other local governmental entities may not impose additional or duplicate requirements or fees or establish a separate program for the permitting of the location, abandonment, boring, or other activities reasonably associated with the installation and abandonment of a groundwater well.”

QUESTION OF THE DAY

Q: How do I know if coursework has been pre-approved for CE credit?

A: The Florida Water Well Administrators Website is updated twice a week with pre-approved coursework offerings. The FWWA has over 75 Providers that are located throughout the state of Florida and deliver numerous courses during the renewal cycle. The FWWA website provides information on course location, date and time, course content, coursework CE approval and contact information for all in-person and online approved coursework. As a reminder, a minimum of six (6) hours must be in the rules/well construction category (R/R), no more than six (6) hours may be in the business/safety practices category (S/B) and you can receive a maximum of three (3) hours online.

RULE 62-531.380, FLORIDA ADMINISTRATIVE CODE (F.A.C.), DISPLAY OF WATER WELL CONTRACTOR LICENSE NUMBER

Contractor's license number shall be continuously displayed in a conspicuous place on both sides of each piece of drilling equipment owned, leased, or operated by the contractor. The number shall be easily readable by a person with normal vision and shall be in a color which will contrast with its background. The number shall be presented in numerals not less than two inches high.
